

WCS CONSERVATION EDUCATION – AFI, MBE, OKWANGWO QUARTERLY REPORT: APRIL - JUNE 2017

SUMMARY: The Wildlife Conservation Society (WCS) has worked to safeguard Africa's great wildlife and wild places for the long-term benefit of the people of Africa, and the world since 1920. Today WCS has the oldest, largest and arguably most effective field conservation program of any NGO in Africa. WCS's mission in Africa is: to save wildlife and wild places by understanding critical issues, crafting science-based solutions and taking conservation actions that benefit nature and humanity. This mission identifies landscapes and species conservation as WCS's core purpose, highlights the role of science in studying threats and designing interventions and recognizes that conservation must benefit people to be effective and sustainable.

During this period, WCS carried out 20 school visits, 8 field trips with 194 students to Mbe Mountains, Cross River National Park and Afi Mountains Wildlife Sanctuary. Other activities include film show in 30 villages with a total of 8,187 viewers, 8 exchange visits, and community meetings. During the period the WCS conservation education coordinator also worked with the Okwangwo law enforcement project manager to carry out a survey of farm encroachment in the Cross River National Park.

Film Show: Great Apes films were showed in 30 villages in Afi, Mbe and Okwangwo Villages of Cross River National Park and viewed by a total of 8,547 persons. The aim of the film show was to enable the people understand the threats facing Cross River gorillas and other endangered wildlife, and to discuss ways to improve their protection. During the film show, discussions focus on farming in protected areas and other factors contributing to habitat destruction. Farm encroachment is a serious issue especially in Afi and Okwangwo.

FIELD TRIP: During this period, eight field trips were organized with schools around the three Cross River gorilla sites with a total of 194 students participating. Four field trips were organized with 4 schools in Mbe, 2 schools in Afi and 2 schools in Okwangwo respectively. The field trips were organize students to learn about biodiversity directly in the field, and about the conservation actions being taken to mitigate the many threat facing wildlife.

They were also used to inspire and motivate the students to contribute to biodiversity conservation.

SCHOOL VISIT: During this period, WCS Conservation Education Coordinator visited twenty schools in all WCS field sites to plan for field trips, and carry other conservation education activities including lessons, gorilla games, and distribution of 1090 Cross River gorilla notebooks. The lesson topic for the period was "Endangered Wildlife Species" and focused on threats to wildlife and the IUCN species assessment criteria.

EXCHANGE VISIT: Eight exchange visits involving sixteen schools were organized for students to share knowledge on conservation issues. A total of 808 students participated in the activity (Table 4). Exchange visit enable conservation club members in schools to share ideas and knowledge they have acquired on conservation issues. Activities implemented during the exchange visits include Cross River gorilla game, poems recitation, quiz competition and conservation drama. These activities were carried out in a competitive manner and all the teachers in the host schools were involved. The students were excited and participated actively throughout the period. Exchange visit enable students and all the schools involved to take conservation activities seriously due to it competitive nature and knowledge acquired.

COMMUNITY MEETINGS/VISIT TO BORDER COMMUNITIES: A total of 9 village meetings were held to discuss conservation issues. Six meetings were held with the Balegete villages, 2 with Okwa I and Okwa II, and one meeting at Boki Paramount Ruler's palace organized by Cross River State Forestry Commission. Issues such as hostility towards park and conservation NGOs field staff and ongoing farm encroachment in the park were aslo discussed. WCS Conservation It was stressed that violence against park staff will not bring the development that communities desire. Communities were advised to contact politicians representing them for assistance with development projects which may be outside the scope of work of conservation NGOs. At the meeting at the Boki Paramount Ruler's palace on 13th of April the Chairman, Cross River State Forestry Commission warned against the increasing illegal activities carried out by communities around Afi and Mbe, especially logging.

Following reports of elephants killed in the Okwangwo-Takamanda border area the WCS conservation education coordinator visited and spent 3 days from in Matene village to carry out investigations. The reports could not be confirmed. The people of Matene reported that the Takamanda project did not favour their community and that motor-cycle roads constructed around the park where limited to Takamanda village and did not extend to Matene. It appears from inforamation gathered in the village that hunters from Matene may be intensifying their hunting in both Takamanda and Okwangwo in protest.

OKWANGWO FARM ENCHROCHMENT SURVEY: A four days survey was conducted by Louis Nkonyu and Emmanuel of WCS to assess the level of farm encroachment Okwangwo. The survey covered areas around Buabre, Yagwanbe, Otsakwai and Oguefor. Other areas visited were Okwa- Butatong road, Okwangwo-Okwa road, Balegete-Okwa road and Bashu-Obonyi axis. In all the areas visited several farms were observed, with many being expanding deeper into the park. The crops planted were cocoa, bananas and plantains. Action needs to be taken by the park authority to stop farm encroachment in the park.
